- ❖ **Cancellation of Exhibit Space** – Upon written notice of cancellation received prior to October 2, 2017, a complete refund will be made. No refunds will be made for cancellations received after that time.
- ❖ **Insurance** – All tabletop materials of the exhibitor are understood to remain under its custody and control in transit to and from or within the exhibit area. Exhibitors must carry appropriate insurance to cover tabletop materials against damage or loss, as well as public liability against injury to the person or property of others. EPS-IA's insurance coverage does not extend to exhibitor's liability.
